Explore your child care support options and start breathing a little easier.

Tuition Benefit offers a 10% discount on tuition rates for full-time, part-time, or drop-in care at KinderCare centers near you, or at Champions before- and after-school programs. Find your location and get the routine, stability, and peace of mind you need.

Four steps to start saving:

- 1 Contact the KinderCare center director or Champions site director at the location where you'd like to enroll your child.
- 2 Schedule a tour.
- 3 Mention this program and provide proof of employment to the director.
- 4 Enroll and start receiving your discount!

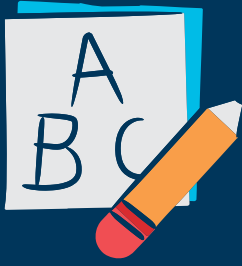
Good news! This benefit applies to both first-time and current KinderCare families!

Frequently Asked Questions

Q: Who is eligible to participate in the KinderCare Tuition Benefit Program that provides a 10% on monthly childcare fee discount?

A: All U.S. Coast Guard (USCG) personnel, enrolled in a participating KinderCare program.

Q: What KinderCare programs qualify?

A: KinderCare Child Care Center (CDC), participating KinderCare at Work Centers, and before and after school programs operating under the KinderCare and Champion's trade names open to the public.

Q: How will KinderCare validate I work for USCG?

A: USCG personnel must provide proof of employment via a pay stub or USCG employee ID.

Q: If I have been enrolled in KinderCare program that participates in the KinderCare Tuition Benefit Program, can I get a retroactive discount?

A: No, discount will be applied once enrolled in the Tuition Benefit Program.

Q: If my KinderCare offers other discounts, can I apply for them all?

A: The KinderCare Tuition Benefit Program discount may not be combined with any other KinderCare available fee discounts, although Employees may select the most favorable available discount.

Q: Am I eligible for the KinderCare Tuition Benefit Program that provides a 10% on monthly childcare fee discount if I will be or currently receive the CG Military Child Care in Your Neighborhood (MCCYN) Fee Assistance (FA) Program?

A: Yes, once you have applied for KinderCare Tuition Benefit Program, the sponsor is required to complete a new MCCYN FA cost worksheet with your child's new fee (fee list should be minus the 10% discount). Have your KinderCare provider sign and upload into your MCC account to support a new claim form being issued.

Note: Only active-duty CG Members or Reserve Members on active-duty orders for 180 days are eligible.

Q: If currently enrolled in the CG Military Child Care in Your Neighborhood (MCCYN) Fee Assistance (FA) Program, when would best time to apply for the KinderCare Tuition Benefit Program?

A: In August when KinderCare updates their fees; or when you enroll into KinderCare program or when your MCCYN FA registration needs to be renewed.
